

Government procurement price of microgrid storage in Ireland

When will long duration energy storage be available in Ireland?

The Irish Electricity Storage Policy Framework, published after this data was collected, indicates that an immediate route to market for 500 MW of long duration energy storage is currently being developed, with further studies planned to support long duration storage from 2030 to 2040 (Government Of Ireland 2024a).

What is the electricity storage policy framework for Ireland?

In line with CAP Action EL/24/16, the Electricity Storage Policy Framework for Ireland (ESPF) was published by my Department in July 2024. The policy framework included 10 Government actions to support the role of electricity storage systems in Ireland's energy transition.

Should 'long duration' electricity storage systems be integrated into Ireland's Electricity Grid?

In this regard, greater emphasis is placed on ensuring 'long duration' electricity storage systems - systems that have the capacity to deliver electricity throughout at least a four-hour period - are integrated into Ireland's electricity grid.

What is EirGrid's long duration energy storage (LDEs) procurement mechanism?

In line with Action #6, EirGrid, in conjunction with the Regulatory Authority, are developing a procurement mechanism for long-duration electricity storage, through their Long Duration Energy Storage (LDES) product. The LDES product is in its initial stages with 2 separate public consultations expected in 2025 and 2026.

Does Ireland need an energy storage policy?

The Irish Government's Climate Action Plan 2021 set out the need for an energy storage policy for Ireland to support 75% reduction in power sector CO2 emissions by 2030. There are 10 key policy actions in the framework outlining the timings and key stakeholders involved in delivering them. Key points:

Does energy storage need a new procurement framework?

A recent report by the storage industry representative organisation, Energy Storage Ireland, has emphasised the need for a new procurement framework for long duration energy storage in particular, and for co-ordinated strategy and stakeholder engagement with regulatory bodies, policymakers and industry (Energy Storage Ireland, 2022).
