The award of public contracts is currently governed in Greece by Law 4412/2016 implementing Public Procurement Directive 2014/24/EU and Special Sectors Directive 2014/25/EU.

The total value of public tenders in Greece was EUR22.7 billion in 2022. This represents 1.7% of Greece's GDP. The Greek government is the largest procurer of goods and services in the country. Bidding for tenders in Greece is extremely lucrative for companies of all sizes.
