All employees in Argentina are entitled to a 13-month salary, which is to be paid in two instalments (on June 30 and December 18). Each salary installment should be equal to 50% of the employee's highest monthly wage for the past six months.

How long does it take to get paid in Argentina?

Payments are made as follows: Payments must be made within four working days for monthly or bi-weekly employees and three working days for weekly employees. Argentinian local law states employees are entitled to receive an additional month's salary, a 13th month salary: Aguinaldo.
