

# Residential ESS project financing options in Greece 2026

What are the requirements to buy a property in Greece?

**Date:** The property should have been constructed prior to 1979. **Energy Performance:** The property must hold a Certificate of Energy Performance (PEA) rated category C or lower.

How do I apply for a property grant in Greece?

**Tax Identification:** Ownership of a Greek Tax Identification Number (AFM) is required. **Application**

**Procedure:** The grant application process involves the submission of: A duly filled application form. A photocopy of the property's title deed. A photocopy of the PEA. A photocopy of the AFM.
