

Solar storage inverter project financing options in Luxembourg 2026

How many solar power plant projects are in Luxembourg?

Following a call for projects launched in October 2022, 85 solar power plant projects by 75 Luxembourg companies qualified for public funding. These projects will receive a total investment aid of EUR 16.1 million. Some of the selected companies received support from Luxinnovation.

When does Luxinnovation open?

It will open in July and run through October 2023. As the national innovation agency, Luxinnovation guides companies during their applications for national and European funding. Some of the companies that responded to the call for projects received support from Luxinnovation.

What is solar leasing & equipment financing?

Solar leasing and equipment financing represent innovative solutions for implementing renewable energy projects without substantial upfront capital investment. Under a solar lease arrangement, property owners can install solar panels by paying regular monthly fees rather than purchasing the system outright.

How much money will a photovoltaic power plant project receive?

The projects will receive a total of approximately EUR 16 million in financial aid. In the next 18 months, these companies will implement the photovoltaic power plant projects with at least partial self-consumption of the electricity produced. The combined capacity of these plants will be over 46-megawatt peak (MWp).

How can a business finance a solar installation?

Equipment financing offers another practical pathway, allowing businesses to spread the cost of solar installations over extended periods. Financial institutions typically provide these loans with competitive interest rates, considering the stable revenue potential of solar installations.

Why does the Grand Duchy need solar energy?

Solar energy is a source of clean energy, which helps the Grand Duchy to achieve its development objectives for renewable energies, and which is one of the solutions to break out of energy dependence on Russian fossils.
