Are foreign contractors taking on EPC contracts in Vietnam?

Foreign contractors have been taking on EPC contracts in Vietnam up until recent years. About ten years ago, Chinese contractors accounted for 90% of EPC contracts for different projects in Vietnam, ranging from electric power, petroleum, metallurgy, extractive to chemical and mechanical.

Do EPC contractors pay personal income tax in Vietnam?

Under current regulations, the employees of EPC contractors working for the Vietnamese project are subject to PIT (Personal Income Tax) in Vietnam, regardless of their actual presence in the country. The Vietnamese customer has to notify EPC contractors of the obligations to pay Personal Income Tax incurred by the foreign employees.

What is an EPC contract?

EPC stands for Engineering, Procurement, and Construction. An EPC contract is a type of construction contract where the contractor takes responsibility for the engineering, procurement, and construction activities of a construction project and delivers a completed final project to the employer or owner.

What are EPC companies?

Hence, EPC companies are involved in engineering, procurement, and construction services on a contract basis. EPC companies primarily engaged in construction projects, however, the sectors they cover can vary. The EPC contract has been in Vietnam since the late 1990s.
