How do EPC contracts work in Poland?

The investment costs, in part or in full, can be repaid from the achieved and guaranteed (under the EPC contract) energy savings, through the visible difference in energy bills. The Polish guidelines for EPC contracts are assigned to public sector entities, encompassing a range of energy efficiency projects.

Will EPC contracts provide for the handover of a solar facility?

EPC Contracts will not provide for the handover of the solar facility to the Project Company, and the PPA will not become effective until all commissioning and reliability trialling has been successfully completed.

What are Poland's new EPC guidelines?

The new EPC guidelines offer a structured approach to improving energy efficiency, particularly in public sector projects. This move is a part of Poland's strategic energy policy, aiming for a more sustainable and efficient energy use across the country, and reinforcing the nation's commitment to energy efficiency and climate goals.
